## PAVILION RENTAL TERMS AND CONDITIONS

A deposit equal to the rental fee is required at the time of booking to confirm the date.

**DEPOSIT** 

BEVERAGES	All beer, wine, alcohol and non-alcoholic beer must be purchased and supplied by the Liederkranz. No alcohol may be brought onto Liederkranz property. No alcohol may be removed from the premises. Applicant may bring soda and bottled water.		
ICE	The Liederkranz does not supply ice for pavilion rentals.		
<b>BARTENDER(S)</b>	When alcohol is being served, Applicant must use a Liederkranz R.A.M.P. (Responsible Alcohol Management Program) Certified Bartender. If event has over 100 people, two (2) Liederkranz bartenders are required. Bartender Fee: \$20.00 per hour per bartender for a minimum of four (4) hours.		
SPECIAL RENTALS	Special rental requests such as tents and/or additional tables must be arranged through the Liederkranz and will incur a surcharge. Please submit your request for quote prior to signing this agreement.		
PORT-A-POTTIES	Port-a-Potties are provided for all rentals. A handicap restroom is available.		
DECORATIONS	Applicant shall not use staples, tacks, or glue on any of the pavilion tables, walls, ceiling, wood surfaces, or any other Liederkranz property. Applicant will remove all decorations at the end of the event.*		
TABLE SET-UP	Applicant may move tables; however, tables must be returned to their original position at the conclusion of the event.*		
TRASH	Applicant shall remove all trash at the end of the event to the trash bin located in the parking lot.*		
SURCHARGE	*Any decoration removal, table reset, or trash removal by the Liederkranz will result in forfeit of the rental deposit and/or additional surcharges.		
	The Lancaster Liederkranz has a small games of chance license which covers raffles and 50/50 for the Liederkranz only. Individuals or groups that book the facility and wish to hold raffles or 50/50's must secure a small games of chance license or a special permit license for that event.
